Where is my Organization in Project Development?

- **Idea Stage**
 - Project concept and feasibility
- **Project Planning Stage**
 - Defining project goals, scope, resources, and purpose
- **Shovel Ready Stage**
 - Execution of the project can happen quickly





Is my Project Appropriate for Federal Funding?

Alignment

- Does this program fit or fulfill your organization's mission, vision, or values
- Ensure the project aligns with the federal opportunity's goals

Eligibility

- Is my project eligible?
- Is my organization eligible?

Resources

- Does my organization have the resources to apply and manage a federal award?
 - Staff
 - Budget and timeline
 - Partners

Types of Federal Financial Assistance

The Bipartisan Infrastructure Law includes a range of funding opportunities for various stages of an organizations project readiness:

- **Technical Assistance**
 - Ex: EPA Water Technical Assistance (WaterTA)
- **Planning and Design**
 - Ex: Rebuilding American Infrastructure with Sustainability and Equity (RAISE)
- **Construction**
 - Ex: Bridge Investment Program (BIP)

Before You Apply – The Basics and Experience

What do you have? What don't you have?

- ✓ Does your organization have any experience with **administering and managing federal, state or local grant funds**?
 - If so, was this in the past 12 months?
- ✓ Is your organization **tracking funding announcements on Grants.gov or on other systems**?
- ✓ If you have administered federal or even local grants in the last 5 years, did you have any **single audit findings, or audit findings**?
 - Did you organization properly review, and address any such findings?

Grant Ready Checklist

Do you have the following in place?

- Policies and procedures
 - Clear internal processes
 - Robust internal controls
 - Federal procurement requirements
- Financial management systems
- Infrastructure needs/priorities identified
- Available matching resources, or know how to identify sources for matching funds

The Bipartisan Infrastructure Law (BIL) represents a major investment in local infrastructure projects. The checklist below allows organizations to evaluate their grant readiness in preparing to apply for BIL funding.
